IF THIS HAPPENS	DO THIS
Vehicle accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. Call the emergency services: Dial 111
Spill or leak	Ensure spill response personnel have adequate protective gloves, goggles and dust filter mask. Wear protective equipment to avoid exposure. Vacuum material with appropriate dust collection filter in place. Be aware of potential for dust explosion when using electrical equipment. If vacuum is not available, lightly mist material and remove by sweeping, scraping or wet wiping recoverable material into a labelled container. Transfer to a waste container labelled as "Hazardous Waste". Dispose of to an approved landfill. Large spills due to traffic accidents, etc., should be reported immediately to the HAZMAT Fire service team by dialling 111. Prevent spilled material from flowing onto adjacent land or into streams, ponds, or lakes.
Fire	Call the Fire Service: Dial 111. Toxic fumes are likely to be formed in a fire.

FIRST AID

If swallowed	Rinse mouth. Do NOT induce vomiting. Never give anything to the mouth of an unconscious person. Immediately call a POISON CENTER or physician.
If in eyes	Rinse cautiously with water for 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Seek medical assistance if needed.
If on skin	Wash with plenty of soap and water. Wash contaminated clothing before reuse. If skin irritation or rash occurs seek medical assistance.
If inhaled	Remove to fresh air and keep at rest in a position comfortable for breathing. Seek medical assistance if needed.

STORAGE AND SEGREGATION

Storage: Store locked up in a cool, dry clean area away from food or feedstuffs. Keep out of reach of children.

Aggregate Storage Volume Thresholds: When stored with substances of the same hazard the aggregate quantity must be considered. For full details refer to the current NZS8409 Management of Agrichemicals and the HSNO Regulations.
